# President, Secretary & CEO/ General Manager's Report

# Over the past 50 years your cooperative has witnessed tremendous

change in the telecommunications industry. An industry focused primarily on connecting the world with hard-wired telephone lines is now delivering communications over fiber optic glass connectivity. A smartphone or device connects wirelessly and travels over fiber optic cables to connect with friends and family worldwide. The internet has truly transformed ECTC – Tremolo Communications and the industry.

As internet service enhances voice and video technology, the need for traditional telephone lines has decreased. Also, with additional streaming options, traditional video viewing habits are changing. Tremolo Communications continues to focus on providing a first-class internet service to our members and expanding to underserved areas.

In 2023, the coop experienced growth by expanding its borders to Ideal and Jenkins Townships and the city of Jenkins. Contractors installed approximately 125 miles of fiber throughout the area, making service available to approximately 2,000 business and residential locations. Home-based businesses, remote working options, and online education drive our area's need for internet connectivity. The coop continues to pursue these growth opportunities to remain viable in our communities.

As Tremolo Communications expands, internet usage continues to increase exponentially, with added users and additional devices that connect to the internet. Throughout 2023, the coop continued to make substantial investments in the all-fiber network, rolling out necessary network upgrades to process the additional internet traffic. The primary services that drive high-volume usage include:

- Video streaming and conferencing
- Online gaming
- Music and photo downloads
- Smart home solutions
- Multiple devices connected to the internet simultaneously

This past year, Tremolo Communications also upgraded business and residential email and spam filtering services. The new email service provides members with robust spam and virus protection and easy to access webmail. As malicious email scams and other cyber threats continue to increase, it is essential to provide the best service possible and up-to-date equipment, reducing exposure to our members.

The Tremolo Team rolled out streaming video in 2023. The TremoloTV app is now available on Amazon Firestick, Roku, and Apple TV devices. Instead of requiring a set-top box for each TV, members can download the TremoloTV app on a compatible device, enter account information, and you're streaming. As traditional viewing habits transition to streaming, an area that has stayed the same is increased programming costs. Programmers continue to force high annual increases to carry their channels. Tremolo Communications is a member of the National Content & Technology Cooperative (NCTC), representing over 700 service providers, and continues negotiating with these national programmers to keep programming costs as low as possible for our members.

On behalf of the Board, Management, and the Tremolo Team, I would like to thank the entire membership for a great year. I look forward to the future of the coop and to providing our members with quality local services. I hope everyone can attend the 50th Annual Meeting!

#### **Report of Nominating Committee:**

Ms. Raph gave the nominating committee report. Mr. Hawley applied for Little Pine, District 4 board position. The committee met March 8th and April 12th.

President Hawley asked the membership present if all ballots had been turned in. He then closed the election, and the ballots were taken to be counted by the nominating committee.

#### **President's Report:**

President Hawley gave his 2023 annual report. As a cooperative, our company relies on the member owners to operate and fulfill its obligations. Community service in the form of high-quality telecommunications products and to be service oriented in interactions with current and potential customers is the goal.

The availability of state and federal grants has created the ability for our company to bring high-speed internet to neighboring areas. This gives our company a larger geographical area and customer base.

The board's role is oversight and advice not management. I and the rest of the board are thankful for the excellent job done by our terrific management team and excellent union employees.

## Financial Report:

Ms. Porta, Accounting Manager, gave the financial report.

- Total revenues are up \$455,000.
- Assets increased to \$6,900,000.
- $\cdot$  Investments are down

## **General Manager Report:**

General Manger/CEO Mr. Netland welcomed everyone to the 49th annual meeting and gave the following updates:

Mr. Netland introduced the ECTC employees and thanked them for their hard work and commitment. He recognized the employees retiring in the past year.

Reviewed Strategic Planning – The board of directors and management conduct Strategic Planning meetings annually or at a minimum every other year. Two main areas of focus out of these meetings are:

- Review and update coop's mission statement which is -Emily Cooperative Telephone Company provides reliable, secure communications and technology with a positive customer experience.
- Identify strategic objectives to assist with the direction of the coop on a 3-5-year plan.

The current strategic objectives include:

- Growth expand membership/service area.
- Economic Development market area/communities
- Partnerships focus on current and new partnership opportunities.

The reasons these objectives are important for the coop:

- Remain viable in our communities.
- Keep our communities connected eLearning, work from home, ability to run your business. - Estimated 40 million people work from home in the United States
- Create employment opportunities.
- Internet adoption, importance of service, rely on service for communications.
- The transition from voice to internet, decline in voice and long-distance revenues.
- Replacement strategy for universal service support revenues.

Mr. Netland reviewed a map of traditional ILEC area along with current and past projects since 2020.

The streaming video platform to be launched towards the end of 2023 was introduced to the members.

Mr. Netland discussed Cybersecurity awareness.

Additional coop updates included capital credit distribution and bylaw updates.

## **Election Results**:

The bylaw changes (listed below) passed with 86 yes and 2 no votes.

- Flexibility to schedule when the annual meeting is held and allows the board to select a date.
- Current bylaws consistently refer to telephone service which would be modified to services (cable, broadband, other communication)
- Change "husband, wife" in current bylaws to joint membership (any two or more adult residents in the same household)
- Remove compliance requirements of Rural Utilities Services as the Co-op no longer is a party to a loan with them.
- Allows the board to use reasonable discretion in determining "conflict of interest" to serve on the board.

## **Grand Prize drawing winners:**

From the By-laws of Emily Cooperative Telephone Company Section 4, of Article 3

Section 4. Nominations and Elections. It shall be the duty of the Board of Directors to appoint, not less than one hundred twenty (120) days before the date of a meeting of the members at which directors are to be elected, a committee on nominations consisting of not less than five (5), nor more than nine (9) members who shall be selected so as to include at least one member from each such districts. No member of the Board of Directors may serve on such committee. The committee, keeping in mind the principle of equal representation, shall prepare and post at the principal office of the Cooperative at least thirty (30) days before the meeting a list of nominations for directors which shall include at least two candidates for each director to be elected. Any fifteen (15) or more members acting together may make other nominations by petition not less than twenty (20) days prior to the meeting and the Secretary shall post such nominations at the same place where the list of nominations made by the committee is posted. No member may nominate more than one candidate.

A ballot marked "Ballot of Directors" containing the names of all the nominees so posted alphabetically arranged and stating the residence of each along with space for a write-in voting shall be mailed with the notice of the meeting. The Secretary shall also mail with the notice of the meeting a statement of the number of directors to be elected and showing separately the nominations made by the committee on nominations made by petition. Such statement of the Secretary shall also inform the members of the manner in which they may vote by mail for directors as provided in this section.

Any member who is absent from any such meeting may vote for directors by marking on the ballot an "X" opposite the names of the number of candidates equal to the number of directors to be elected. Absentee ballots may be returned by mail or delivery, but must be received by the Cooperative prior to the meeting. Absentee ballots shall be enclosed in a sealed envelope marked "Absentee Ballot for Directors Enclosed." The sealed envelope must be signed by the absentee member. The sealed and signed envelopes shall be kept unopened until all ballots have been cast during the meeting. If a husband and wife hold a joint membership and are absent from such meeting, they may vote for directors by jointly marking and enclosing the ballot hereinabove provided for. Notwithstanding anything in this section contained, failure to comply with any of the provisions of this section shall not affect in any member whatsoever the validity of any election of directors.
